PUBLIC NOTICE

formulated in the Italian and English language by the Movimento Trieste Libera – Gibanje svobodni Trst – Bewegung Freies Triest – Free Trieste Movement, political organization with the character of an international subject, that represents the rights and legitimate interests of the citizens *de jure* and of the residents of the current Free Territory of Trieste as well as protecting the interests of all States of the International Community and of the European Union to the full, correct and undisturbed use of the international Free Port of Trieste, by virtue of the mandate of its members and of more than 20,000 signatures that it has already collected for this purpose, 15,000 of which in particular, to request the Security Council of the United Nations, the international guarantor of the Free Territory of Trieste, the re-establishment of its correct special trusteeship established under Resolution No. 16/1947 of the Security Council and under the Treaty of Peace between the Allied and Associated with Italy, signed at Paris on 10 February 1947.

1. The Free Trieste Movimento reminds to the provisional Italian Government, entrusted with the temporary civil administration of the Free Territory of Trieste, and to the Commissar of the Government delegated to this function that at 12AM of tomorrow, 15 September 2015, expires the term of the public «FORMAL INVITATION TO COMPLY WITHIN 90 DAYS TO THE OBLIGATIONS ESTABLISHED UNDER INTERNATIONAL AND ITALIAN LAW IN REGARD TO THE FREE TERRITORY OF TRIESTE, OF ITS CITIZENS AND RESIDENTS, ITS ENTERPRISES AND ITS INSTITUTIONS» notified in the Italian and English language on 15 June 2015 and sent, for information, to the Security Council of the United Nations as well as to the President of the European Parliament in regard to the dispute procedure

opened with petition dated 3 June 2015, that in the meantime was supported with international adhesions and new evidences.

- 2. The Free Trieste Movement makes is clear that the refusal or the failure of the fulfillment required would constitute a public, formal resignation of the Italian Government from the international mandate of temporary civil administration, entrusted to its responsibility on behalf of the Security Council of the United Nations by virtue of the Memorandum of Understanding of London of 5 October 1954, as an additional implementing act to the Treaty of Peace of 10 February 1947, successor of the Allied Military Government Free Territory of Trieste A.M.G. F.T.T. that took office on 15 September 1947 as first provisional Government of State of the current Free Territory of Trieste.
- 3. Therefore, the Free Trieste Movement confirms that starting with tomorrow, 15 September at 12AM it will take care of the formal verifications of this possible refusal or omissions committed by the administering Italian Government and by the Commissar it has delegated.
- 4. Where this refusal or omission s found, the Free Trieste Movement is taking care to promptly activate the needed legal remedies under international and domestic law arranged for the case, which are to be published on Monday, 21 September 2015.
- 5. The present "Public notice" in the Italian and English language is notified and published for all consequent legal terms.
