The Free Trieste Movement stops the illegal operation of the bosses of the PD on the Free Port

The Free Trieste Movement has found and activated, with the suitable actions, the instruments to block the legal possibilities of the illegal operations with which the bosses of the PD (Serracchiani, Rosato, Russo, Cosolini) are attempting to destine the Northern Free Port of Trieste to the housing and building speculation, trying to sell it as urban renewal.

In facts, the Northern Free Port is an indispensable structure for the development of the international Free Port of Trieste, and the fake urban renewal is under serious anti-mafia questions both for precise facts and since it does possibly allow money laundering for an amount of 1,5 billions Euro.

But the investigators in charge of this outside Trieste affirm that this is nothing but the visible edge of the *Eisberg*, since suffocating the Free Port of Trieste is part of a colossal robbery that is going on since a long time, even with the political support of Mr. Rosato and Ms. Serracchiani.

This is the operation to permanently divert the future traffics on the Baltic-Adriatic and Transsiberian routes from the international Free Port of Trieste (and the nearby ports of Koper, Slovenia and Rijeka, Croatia) to the ports of Southern Italy which are most strictly controlled by organized criminality: Naples, Gioia Tauro, Taranto, Bari.

In Trieste, poverty increases on a daily bases, leading people, families and enterprises on the edges of an humanitarian emergency made of loss of jobs, unemployment, expropriations of houses and starvation. But the bosses of the PD attempt to suffocate the international Free Port, economic engine for several thousand working places - direct and indirect - to offer these to Italian ports and turn Trieste into a regional port. Doesn't it seem odd?

They did go as far as sabotaging, unpunished, the concessions of port areas, receiving an illegitimate judgment from the TAR - Regional Administrative Court in order to move our Free Zones in Friuli, deceiving the Italian Parliament with the three fraud-amendments of Senator Russo to the Italian Financial Law for year 2015 and seizing, with abnormal political pressures, the Port Authority.

This is not politics. It is irresponsabilità and political delinquency at the expenses of our unfortunate people. This means betraying the city that those people, disguised as progressive politicians had to elect them by chatting, promising and expensive electoral campaigns.

And, by now, it is clear that if we do not stop them in time they will destroy the only real possibilities for the city to raise again - the international Free Port, drowning it in a future made of misery and irreversible marginalization.

Facing the never seen before arrogance of those bosses of the PD and their reverent newspaper, *Il Piccolo*, many people of Trieste have given up and reassigned to the worst to come, even between businessmen and port operators.

Instead, the Free Trieste Movement continues the struggle, and it had found both the weak point in the arrogant illegal system of the bosses of the PD about the Northern Free Port, and of the

instrument to exploit it: the weak point is the area and the instrument is the Austrian Land Registry Law, the *Grundbuchgesetz* which is still in force in Trieste. Once again, Austria saves us.

Under the Land Registry Law, contrarily to Italy, here the ownership and the rights on immovable properties are demonstrated and enforced with the registration on the Land Registry, the *intavolazione*, which takes place on the bases of the titles of legitimation presented.

The State Property of the Republic of Italy has never registered the ownership of the Northern Free Port, because it has no title to do that since the Treaty of Peace of 1947 established the Free Territory of Trieste ending Italian Sovereignty and transferring all Italian State and para-statal properties to the Free Territory, assigning to the Free Port these within its boundaries.

Therefore, the only valid registration for these is that of “*Demanio dello Stato del Territorio Libero di Trieste, Porto Franco internazionale di Trieste*” - “*State Property of the Free Territory of Trieste, international Free Port of Trieste*” under the Treaty of Peace, in force and implemented in the Italian legal system, which means its bodies must enforce it and cannot oppose prevailing titles to it.

On April 17th, the Free Trieste Movement had begun the procedure to correctly register the ownership of the Northern Free Port in fulfillment of the Treaty of Peace, as well as the registration of the restrictions of international Free Port in favor of all the States - which are notified of that - and the obligation to solve any dispute with the special procedure envisioned by the Treaty, not before ordinary civil Courts.

So, even the system of the fraud- amendments of senator Russo ends up in the trash. Because the Commissar of Government cannot move the regime of Free Port violating the Treaty of Peace - which was registered as well - and the State Property of the Republic of Italy cannot transfer to the Municipality a property which does not belong to it. Even so, the acts would be null and void as well as constituting a crime.

And if they oppose to us the well-known fake thesis that the Free Port has become *res nullius*, nobody's land, at the ceasing of Italian sovereignty and the failure to establish the Free Territory, the demand that was presented would lead to the assignation of the property to the first petitioners, us, who would then transfer it to the Free Territory.

Chessmate. Right in the face of the arrogant bosses of the PD, of the system of corruption of Italy which attempts to suffocate the international Free Port of Trieste, and the interests of the Mafia which was counting on this operation were deceived by who promised to them what they they could not give. And not even killing us would change it, because the registration under the Treaty of Peace must be done, even *ex officio*.

Of course, the battle has just begun, but the immediate effect is that all the illegal operation forced by the PD against the Northern Free Port remain blocked, even on a financial level, since when the titles of ownership are missing or under question, neither banks nor public or private investors would fund it. And it won't be enough staying silent, bidding the news - the way the politicians involved and Il Piccolo did in the past days.

So, the ones who believed they could take advantage of the economic crisis and of the political and institutional corruption of Italy to conclude, by force, in year 2015 the sack of Trieste that had begun in 1918 - that was stopped in 1947 and restarted in 1954 - must understand that it is all over.
